THERE ARE SEVERAL DISCOUNTS AVAILABLE TO YOUR CHAPTER.

PAY ON TIME: A 10% discount will be applied for all dues and Health & Safety fees if paid in full by September 1 for fall quarter and quarter fees, February 1 for spring quarter and winter quarter fees, and April 1 for spring quarter fees.

EDUCATE NEW MEMBERS AND COMPLETE THE ONLINE HEALTH & SAFETY COURSE: If your New Members completes the Online Health and Safety Seminar, within 30 days of induction, the chapter will receive a discount of \$35 per New Member.

QUALIFY FOR HEALTH AND SAFETY DISCOUNTS: Please work with your Educational Leadership Consultant (ELC) or Regional Director to qualify for the discounts listed below.

DUE TO RISING CLAIMS IN THE INDUSTRY, WE ARE ANTICIPATING ANOTHER INCREASE IN INSURANCE COSTS FOR 2023-2024. DISCOUNTS WILL BE AVAILABLE TO YOUR CHAPTER STARTING THIS FALL BASED ON THE ACTIVITIES OF YOUR CHAPTER DURING THE 2021-2022 SCHOOL YEAR. THESE DISCOUNTS WILL CONTINUE IN 2023-2024. BY TAKING ADVANTAGE OF THESE DISCOUNTS, YOUR CHAPTER WILL HELP US TO BE BETTER EQUIPPED TO NEGOTIATE FUTURE RATES WITH OUR CARRIERS.

If 90% of your chapter attended an approved Health & Safety Seminar during the 2021-2022 school year and submitted proof of completion to their ELC, the chapter will receive a discount of \$6.67 per Brother in the fall.

If 100% of your chapter completed the GL.edu course, as of the billing date, the chapter will receive a discount of \$6.67 per Brother in the fall.

If your chapter Master attended the AEPi Master's Academy in January, the chapter will receive a discount of \$3.33 per Brother in the fall.

If your chapter maintained an active Judicial Board during the 2021-2022 school year, the chapter will receive a discount of \$3.33 per Brother in the fall.

In addition, if your chapter structure (Eboard, Minor Board, JBoard) is consistent with the AEPi model, your chapter will be eligible for a \$5 per Brother discount starting in the fall of 2023.

Either your ELC or Regional Manager will be working with you on the above items so that you are able to take advantage of lower costs of membership and pass savings along to participating chapters.
